1. 1. Complete, detailed declaration required for submission to censor board, allow 3 weeks for delivery. 2. If for commercial purposes, certification from manufacturer is required stating that the items are original and the consignee is authorised by the manufacturer to sell the goods.
2. Health Authorisation requirements for approval: 1. Health Certificate from the country of origin. 2. Dioxin-Free Certification if Belgium origin. 3. Japanese Encephalitis-Free Certification if Japan origin. 4. Radioactive-Free Certification if from European Countries.
3. Military epaulette/badge: approval from MOD/Police HQ require and a Tender/Authorization letter to the consignee from MOD/Police HQ.
4. Approval from Telecom department required. Allow 1 week delay.
5. Phytosanitary permit required.
6. 1. Used telecom equipment-Brunei customs required Regular.Papers/Certificate from shipper &/or country of origin , plus Import Permit from consignee approved by JTB Brunei official. 2. New telecom equipment-Customs require Import Permit approved by JTB Brunei.
7. Prayer mats: approval from Ministry of Religious Affairs require ; delay: 2-3 days.
8. Toy guns: Prohibited.
9. Islamic/Arabic handicraft: approval from Ministry of Religious Affairs req; delay: 2-3 days.

Service Impact Notes

Operation Notes

1. All shipments require consignee's telephone number to be stated .2. Any item which has the Brunei National logo require approval from the ADAT ISTIADAT of Brunei.
