3. Certificate of Origin, Laboratory Analysis with all specifications from origin, Import License, regardless of weight.

4. Certificate of Origin, Phytosanitary Certificate, Import License. This also includes coffee seeds, regardless of weight.

5. Import Permission extended by Health Ministry, regardless of weight.

6. Special permit from Guatemalan government (communications authorities) required. Permit must be obtained by consignee.

7. If sample, Invoice must state"Muestras para registro" and should be consigned to a laboratory. If for personal use, prescription elaborated in Spanish by a doctor, provided by consignee. Large quantities require import permit and prior registration in Public Health Department by consignee

8. If sample, invoice must state "Muestras para registro" and should be consigned to a laboratory. If for personal use, prescription elaborated in Spanish by a doctor, provided by consignee. Large quantities require import permit and prior registration in Public Health Dept by consignee.

9. Samples must be mutilated, otherwise subject to customs duties. If textile shipments for drawback factories, DHL will not clear unless direct approval of consignee. If DHL handles clearance, import duties will be collected upon delivery.

10. Commercial Invoice must state title, length, running time, content & use/purpose(ie advertising,promotional,training,commercial) and production value. If customs does not agree with stated value, material is inspected & reviewed for value, delay: 10 days.

11. Requires Certificate of health , Certificate of free sale from origin. This includes candies and chocolates, regardless of weight.

12. Samples must be mutilated, otherwise subject to customs duties.

13. Commercial Invoice must state purpose/content of type. (ie commercial, intercompany, information, etc.).

14. Unprocessed: Prohibited.

WPX- Commerical Invoice must state FOB value with detailed cost of insurance and freight. Penalities for non compliance: Commerical Invoice not in Spanish USD5.00 per shipment Commerical Invoice not original 25.00. Proforma invoice USD25.00, Insurance and Freight not stated on invoice USD5.00.

Operation Notes

Commerical Invoice must be original, detailed and typewritten on shipper's original letterhead. Invoice in Spanish preferred if not original or in Spanish, Customs penalties will incur. Proforma invoices are unacceptable. Packing list/Slip is required when importing multi-piece shipments detailing contents of each piece.
