Muslim festivals are respected as National hol. Freight clearance handled by DHL through an agent. MAWB must be consigned to DHL Intl Nig.Ltd. Expect 3-4 working days delay. Freight shpts must have form M and Clean Report of Inspection issued by agents such as Bureau Veritas, Contecna and Swede Control Intertek, depending on country of origin. Contact Nigerian Embassy in origin country for details. Pre-alert & paperwork must be sent to GWY Mgr. - Ensure 100% check for cash shpts.
