1. *Dutiable and controlled by Department of Scientific Services. Delay : 2-3 days. Invoice must state the number bottles per shipment, alcoholic content, brand name, litre per bottle, specify sparkling or still wine. If shipment not cleared within 14 days, will be returned to origin.*
2. *Consignee must obtain import license from the Food Control Department. Delay : 1-2 days.*
3. *If unprocessed, it must be accompanied by CITES Certificate from Origin.*
4. *Title list required. Possible inspection by Films & Publication Department. Delay: 1 day.*
5. *Flashpoint must be above 60.5 centigrade. Otherwise prohibited.*
6. *Subject to approval from Pollution Control Department. Proper packing required. Delay : 1-2 days.*
7. *Subject to approval from Telecommunication Authority of Singapore. Mass distribution requires import license from consignee. Delay : 1-2 days.*
8. *Including CD ROM, DVD (Digital Versatile Disc). Title list required. Possible inspection by Films & Publication Department. Delay: 1 day.*
9. *Subject to approval from Drug Administration Division. Consignee must provide product license. Otherwise expect delays for processing license. Invoice must state name of medicine, brand name, reason for import, product composition, quantity .per bottle & weight .of each capsule*
10. *Shipper must provide Phyto Certificate*
11. *Subject to drug administration division's approval, consignee require import license .If private individual contents must have Doctor's prescription. Invoice must have medicine name, brand, quantity per bottle, weight of each capsule, reason for import, product composition & whether contents are raw material or finished product.*
12. *A Films & Publication Department's approved list of games titles required from consignee. Delay: 1-2 days.*
13. *Title list required. Subject to censorship and approval by Films & Publication Department. Delay: 1-7 days.*
14. *Training and industrial advertising and promotion materials for internal company use require consignee declaration to Films & Publication Department. Delay: 1-2 days.*
15. *Subject to approval from Trade Development; Delay: 1 to 2 days.*

- 16.** *Including DVD (Digital Versatile Disc). Title list required. Subject to censorship and approval by Films & Publication Department. Delay: 1-7 days.*
- 17.** *For personal consumption, consignee needs to obtain Doctor's prescription. For retail purpose, consignee needs to obtain import license from Drug Administration Department. Otherwise, delay: 2-3 days.*
- 18.** *Subject to inspection and approval by Arms and Explosives Branch. Delay : 1-2 days.*
- 19.** *Consignee to obtain import permit from relevant government authorities prior to shipping. Fax paperwork and flight details for pre-clearance.*
- 20.** *Dutiable but not controlled. Delay : 1 day. Invoice must state the number of packages in shipment or weight per shipment, brand name and number of Stickers per package. If shipment not cleared within 14 days, will be returned to origin.*
