The importation into the United States from Iran (or a third country) of ONLY the following Iranian-origin commodities are authorized: Foodstuffs intended for human consumption, carpets and other textile floor coverings and carpets used as wall hangings. Note following WPX restrictions:

3. Invoice must state "Not restricted article per IATA regulations." Otherwise, shipment will be held until shipper or consignee is contacted for identification.

5. If drug is available in U.S., importation is prohibited for U.S. citizens. If unavailable in U.S., U.S. and foreign citizens can import. Name of drug, quantity, dosage, letter from tending U.S. doctor for U.S. citizens and proof of foreign citizenship for NonUS citizens. 90 day supply only.

6. Used personal effects only: consignee's phone, flight number, arrival date and passport number or SSN needed. Company to company or company to person (personal purchase) exact description, fiber content and value breakdown needed. Clothing, fabrics and fabric samples, textile products: original Visa may be required unless 1)marked on samples valued up to USD800, "sample" written in indelible ink INSIDE of garment; invoice and AWB must state "marked samples" or 2)mutilated samples value under USD2000, cut and stamped with indelible ink OUTSIDE of garment. Invoice and AWB must state "mutilated samples" or 3) Gift of personal use. Shipments containing solid wood packing material from China and Hong Kong must be accompanied by apropos treatment certificate issued by authorized agency.

 Meat and meat products unacceptable. Other foodstuffs may require U.S. Dept of Agriculture, Food & Drug inspection and/or import permit; additional delay: 2-5 days.
A CF3299 (Declaration for free entry of personal effects) should be completed prior to the importation of personal effects over USD200.

9. Value to USD250 or marked/mutilated samples to USD800 clear informally. Footwear with fabric are formal entries.

10. A consignee Power of Attorney is required. If Power of Attorney is not on file, possible delay of 1-3 days.

Importations requiring special handling such as TSCA chemicals, American Goods Returned and Carnets should be adequately described on the manifest, preferably with terms such as "TSCA," "AGR" and "Carnet." Shipments of fiber/textile products or shipments for human consumption can be delayed 1-3 days for inspection by government agencies other than Customs.
